SUBJECT: Repair of the Public Safety Complex's Heating, Ventilation and Air

Conditioning (HVAC) system

STRATEGIC PRIORITIES:

Unify Downtown & the Waterfront

SYNOPSIS:

Request approval of Budget Resolution No. 2769, amending the FY-2019 Operational Budget to support the repair of the Public Safety Complex's Heating, Ventilation and Air Conditioning (HVAC) system.

FISCAL/STAFFING STATEMENT:

Total cost to repair the system is \$30,851. This cost was determined as a result of the ten vendor quotes received in response to posting of solicitation number IRFQ 18/19-121.

BACKGROUND:

During early October of this year the contracted vendor that performs the scheduled maintenance of the Public Safety Complex's (PSC) HVAC system determined that the chiller coils on the number one chiller unit are failing. This was confirmed through consultation with the Public Works Director as well as multiple HVAC vendors who provided quotes in response to solicitation IRFQ 18/19-121. Warranty coverages on all components of the HVAC system expired five years following the November 2010 initial occupancy of the PSC. It is imperative that the chiller coils on number one chiller be replaced during the cooler weather months of 2019 to prevent the inevitable complete failure of the HVAC system during the heat of the subsequent summer months.

LEGAL REVIEW:

No legal review requested of the City Attorney.

RECOMMENDATION:

It is staff's recommendation that the City Commission approve Resolution No. 2769, amending the FY-2019 Operational Budget to support the repair of the PSC HVAC system.

SUGGESTED MOTION:

Resolution No. 2769

A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2018 and ending September 30, 2019; providing for implementing administrative actions; providing for a savings provision; providing for conflicts; providing for severability and providing for an effective date.

Whereas, the Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2018 and terminating on September 30, 2019 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas, the City's budget presumes that each department generally will, to the best of their ability, maintain its expenditures within its allocated budgeted level and exercise prudence in expending funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget may need revision; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events.

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford, Florida as follows:

Section 1. Adoption of Budget Amendment.

The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2018 and terminating on September 30, 2019 is hereby revised and amended by Attachment "A". The Attachment is hereby incorporated into this Resolution as if fully set forth herein verbatim. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2018 and

terminating on September 30, 2019 shall remain in full force and effect.

Section 2. Implementing administrative actions.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Resolution by means of such administrative actions as may be deemed necessary and appropriate.

Section 3. Savings.

The prior actions of the City of Sanford relating to the adoption of the City budget and related activities are hereby ratified and affirmed.

Section 4. Conflicts.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.

Section 6. Effective Date.

This Resolution shall become effective immediately upon enactment.
