#### Resolution No. 2023-3126

A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2022 and ending September 30, 2023 relating to the work being accomplished by Advanced Recreational Concepts, LLC at Mike Kirby Park and Pinehurst Park for playground repairs; providing for implementing administrative actions; providing for a savings provision; providing for conflicts; providing for severability and providing for an effective date.

Whereas, the Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2022 and terminating on September 30, 2023 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas, the City's budget presumes that each department generally will, to the best of their ability, maintain its expenditures within its allocated budgeted level and exercise prudence in expending funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget may need revision such as the work being accomplished by Advanced Recreational Concepts, LLC at Mike Kirby Park and Pinehurst Park for playground repairs; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events.

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford, Florida as follows:

Section 1. Adoption of Budget Amendment; Work by Advanced Recreational Concepts, LLC at Mike Kirby Park and Pinehurst Park for Playground Repairs.

The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2022 and terminating on September 30, 2023 is hereby revised and amended by Attachment "A" for work by Advanced Recreational Concepts, LLC at Mike Kirby Park and Pinehurst Park for playground repairs. The Attachment is hereby incorporated into this Resolution as if fully set forth herein verbatim. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2022 and terminating on September 30, 2023 shall remain in full force and effect.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

#### Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.



#### SYNOPSIS:

Approval of Resolution No. 2023-3126, to amend the City budget and procure goods and services from Advanced Recreational Concepts, LLC for the repair of playground equipment at Mike Kirby Park And Pinehurst Park due to Hurricane Ian is requested.

#### FISCAL/STAFFING STATEMENT:

Funding in the amount of, \$12,208 requested from the Hurricane Reserve Fund.

#### BACKGROUND:

The request is to fund and purchase the repairs to two playgrounds, located at Mike Kirby Park and Pinehurst Park. The playground equipment sustained damage to shade canopies and from a limb falling on a chain climber. The chain climber will need to be replaced, and then have the safety surface repaired. City staff has removed the chain climber for safety reasons pending its replacement.

The contract for the needed goods and services is with Advanced Recreational Concepts, LLC of Melbourne, under piggyback contract PBA 19/20-27 under Clay County Contract RFP 18/19-2.
