Resolution No. 2024-3280

A Resolution of the City of Sanford, Florida, amending the City's annual operating budget for the fiscal year beginning October 1, 2023 and ending September 30, 2024; providing for implementing administrative actions; providing for a savings provision; providing for conflicts; providing for severability and providing for an effective date.

Whereas, the Commission of the City of Sanford, Florida has adopted an annual operating budget for the fiscal year beginning October 1, 2023 and terminating on September 30, 2024 specifying certain projected revenues and expenditures for the operations of Sanford municipal government; and

Whereas, the City's budget presumes that each department generally will, to the best of their ability, maintain its expenditures within its allocated budgeted level and exercise prudence in expending funds during the course of the City's fiscal year; and

Whereas, from time-to-time circumstances and events may require that the original City budget may need revision; and

Whereas, the City Commission, in its judgment and discretion, has the authority to adjust the budget to more closely coincide with actual and expected events.

Now, therefore, be it adopted and resolved by the City Commission of the City of Sanford, Florida as follows:

Section 1. Adoption of Budget Amendment.

The annual operating budget of the City of Sanford for the fiscal year beginning October 1, 2023 and terminating on September 30, 2024 is hereby revised and amended by Attachment "A". The Attachment is hereby incorporated into this Resolution as if fully set forth herein verbatim. Except as amended herein, the annual operating budget for the City of Sanford for fiscal year beginning October 1, 2023 and

terminating on September 30, 2024 shall remain in full force and effect.

Section 2. Implementing administrative actions.

The City Manager, or designee, is hereby authorized and directed to implement the provisions of this Resolution by means of such administrative actions as may be deemed necessary and appropriate.

Section 3. Savings.

The prior actions of the City of Sanford relating to the adoption of the City budget and related activities are hereby ratified and affirmed.

Section 4. Conflicts.

All resolutions or parts of resolutions in conflict with this Resolution are hereby repealed.

Section 5. Severability.

If any section, sentence, phrase, word, or portion of this Resolution is determined to be invalid, unlawful or unconstitutional, said determination shall not be held to invalidate or impair the validity, force or effect of any other section, sentence, phrase, word, or portion of this Resolution not otherwise determined to be invalid, unlawful, or unconstitutional.

Section 6. Effective Date.

This Resolution shall become effective immediately upon enactment.



SYNOPSIS:

Approve Resolution No. 2024-3280, to amend the budget in the amount of \$153,664.01, for Change Order #1 increasing the Central Florida Environmental Corp. purchase order #39125, is requested.

FISCAL/STAFFING STATEMENT:

The total amount requested is available from two different account lines: \$76,640.93 from the Stormwater fund and \$77,023.08 from Utilities fund.

BACKGROUND:

The City of Sanford's Georgetown Storm Sewer Upgrades Project is currently in construction. While excavating there were a number of unforeseen conditions such as a six-inch gas main, electrical, and fiber lines that were not located. There were additional concrete and structural issues between the existing seawall and old seawall along with an old concrete bulkhead under the road. Upon excavating on First Street and Locust Avenue the old cast iron water lines were so deteriorated that the lines kept breaking and flooding the project out, taking days to recover. It was decided to have the contractor replace the ancient lines on Locust Avenue from First Street to Fourth Street. Also included in the Change Order are 160 additional days for the extra work, rain and holidays.

The original contract price is \$4,347,830.50. The new contract price adjusted by Change Order #1 is \$4,501,494.51.

LEGAL REVIEW:

The City Attorney has reviewed and no legal objection.

RECOMMENDATION:

It is staff's recommendation that the City Commission approve Resolution No. 2024-3280 to amend the budget in the amount of \$153,664.01, for change order #1, increasing the Central Florida Environmental Coro, for a new total of \$4,501,494.51 for the Georgetown Storm Sewer Upgrades.
